

## **Tenancy Application Form**

The following information <u>MUST</u> be supplied when submitting applications before we can begin to process your application:

- Photocopy of Photo Identification: Current Drivers Licence, Passport or 18+ Card
- Photocopies of any references from previous tenancy, word processed on a Letterhead.

Please Note If you have never rented before, character references (references from relatives/friends are not considered appropriate). If you sold or have been living in own your home a rates notice is appropriate as proof of ownership.

• Photocopy of Proof of income: Pay Slips, Current Bank Statement, Letter from Employer, Centrelink income statement.

Application processing time is generally 24-48 hours, you will be contacted once we have received an answer from the landlord.

If you are approved for the property you will be required to pay at least one weeks rent as a deposit for the property. If you decide you do not want to take the property after paying this, the deposit will not be refunded. The above one weeks deposit will come off the rent in advance.

Please ensure you have arranged your 4 weeks bond and 2 weeks rent <u>prior</u> to applying for a rental property. The bond and rent in advance must be received in full prior to collecting the keys.

If you need to see department of housing for assistance you will need to do this before or once approved, to ensure you can take the property on the start date you state on the application form.

We do not do Bond Transfers.

Please do not give our office originals, declined applications are shredded immediately for privacy reasons.

Any person aged over 18 to be living at the property must complete an application form.

Please allow yourself adequate time to view property. It can be a difficult process and it's important you make the correct decision.
